Blue Cross and Blue Shield of Minnesota (BCBSMN) Medical Plan Changes for the 2025 Benefits Plan Year

 Blue Cross and Blue Shield of Minnesota (BCBSMN) will no longer be offered as a carrier effective April 1, 2025. Either Aetna or UnitedHealthcare (UHC) will be offered as the replacement carrier for your worksite employees. Impacted worksite employees will be notified during open enrollment of this change.

If your worksite employees do not make an active election during open enrollment they will be mapped to the most comparable plan available, based on home ZIP code eligibility, and the replacement carrier selected.

IMPORTANT! These comparisons are based solely on plan attributes, <u>not</u> cost. **This may not** be the same plan the worksite employee will be mapped to in the benefits enrollment site if they do not actively enroll.

Worksite employees should carefully review their options within the benefits enrollment site to ensure they are <u>actively reviewing and electing</u> the best plan that fits their needs.
